**READ BEFORE SIGNING- PARTICIPANT RELEASE OF LIABILITY**

\* I acknowledge that I will not travel within the common area of the Industrial Center in any manner other than by passenger vehicle, bus, or motorcycle. **If I fail to comply with this rule I shall be subject to have my membership revoked.**
